**STOCHASTIC CALCULUS** RICHARD DURRETT 1996-06-21 THIS COMPACT YET THOROUGH TEXT ZEROS IN ON THE PARTS OF THE THEORY THAT ARE PARTICULARLY RELEVANT TO APPLICATIONS. IT BEGINS WITH A DESCRIPTION OF BROWNIAN MOTION AND THE ASSOCIATED STOCHASTIC CALCULUS, INCLUDING THEIR RELATIONSHIP TO PARTIAL DIFFERENTIAL EQUATIONS. IT SOLVES STOCHASTIC DIFFERENTIAL EQUATIONS BY A VARIETY OF METHODS AND STUDIES IN DETAIL THE ONE-DIMENSIONAL CASE. THE BOOK CONCLUDES WITH A TREATMENT OF SEMIGROUPS AND GENERATORS, APPLYING THE THEORY OF HARRIS CHAINS TO DIFFUSIONS, AND PRESENTING A QUICK COURSE IN WEAK CONVERGENCE OF MARKOV CHAINS TO DIFFUSIONS. THE PRESENTATION IS UNPARALLELED IN ITS CLARITY AND SIMPLICITY. WHETHER YOUR STUDENTS ARE INTERESTED IN PROBABILITY, ANALYSIS, DIFFERENTIAL GEOMETRY OR APPLICATIONS IN OPERATIONS RESEARCH, PHYSICS, FINANCE, OR THE MANY OTHER AREAS TO WHICH THE SUBJECT APPLIES, YOU'LL FIND THAT THIS TEXT BRINGS TOGETHER THE MATERIAL YOU NEED TO EFFECTIVELY AND EFFICIENTLY IMPART THE PRACTICAL BACKGROUND THEY NEED.

**DIRICHLET FORMS AND ANALYSIS ON WIENER SPACE** NICOLAS BOULEAU 1991-01-01 THE SUBJECT OF THIS BOOK IS ANALYSIS ON WIENER SPACE BY MEANS OF DIRICHLET FORMS AND MALLIAVIN CALCULUS. THERE ARE ALREADY SEVERAL LITERATURE ON THIS TOPIC, BUT THIS BOOK HAS SOME DIFFERENT VIEWPOINTS. FIRST THE AUTHORS REVIEW THE THEORY OF DIRICHLET FORMS, BUT THEY OBSERVE ONLY FUNCTIONAL ANALYTIC, POTENTIAL THEORETICAL AND ALGEBRAIC PROPERTIES. THEY DO NOT MENTION THE RELATION WITH MARKOV PROCESSES OR STOCHASTIC CALCULUS AS DISCUSSED IN USUAL BOOKS (E.G. FUKUSHIMA'S BOOK). EVEN ON ANALYTIC PROPERTIES, INSTEAD OF MENTIONING THE BEURING-DENY FORMULA, THEY DISCUSS "CARR" DU CHAMP OPERATORS INTRODUCED BY MEYER AND BAKRY VERY CAREFULLY. ALTHOUGH THEY DISCUSS WHEN THIS "CARR" DU CHAMP OPERATOR EXISTS IN GENERAL SITUATION, THE CONDITIONS THEY GAVE ARE RATHER HARD TO VERIFY, AND SO THEY VERIFY THEM IN THE CASE OF ORNSTEIN-UHLENBECK OPERATOR IN WIENER SPACE LATER. (IT SHOULD BE NOTICED THAT ONE CAN EASILY SHOW THE EXISTENCE OF "CARR" DU CHAMP OPERATOR IN THIS CASE BY USING SHIGEKAWA'S H-DERIVATIVE.) IN THE PART ON MALLIAVIN CALCULUS, THE AUTHORS MAINLY DISCUSS THE ABSOLUTE CONTINUITY OF THE PROBABILITY LAW OF WIENER FUNCTIONALS. THE DIRICHLET FORM CORRESPONDS TO THE FIRST DERIVATIVE ONLY, AND SO IT IS NOT EASY TO CONSIDER HIGHER ORDER DERIVATIVES IN THIS FRAMEWORK. THIS IS THE REASON WHY THEY DISCUSS ONLY THE FIRST STEP OF MALLIAVIN CALCULUS. ON THE OTHER HAND, THEY SUCCEEDED TO DEAL WITH SOME DELICATE PROBLEMS (THE ABSOLUTE CONTINUITY OF THE PROBABILITY LAW OF THE SOLUTION TO STOCHASTIC DIFFERENTIAL EQUATIONS WITH LIPSCHITZ CONTINUOUS COEFFICIENTS, THE DOMAIN OF STOCHASTIC INTEGRALS (IT) -RAMER-SKOROKHOD INTEGRALS), ETC.). THIS BOOK FOCUSES ON THE ABSTRACT STRUCTURE OF DIRICHLET FORMS AND MALLIAVIN CALCULUS RATHER THAN THEIR APPLICATIONS. **AN INTRODUCTION TO MATHEMATICAL FINANCE WITH APPLICATIONS** ARLIE O. PETERS 2016-06-17 THIS TEXTBOOK AIMS TO FILL THE GAP BETWEEN THOSE THAT OFFER A THEORETICAL TREATMENT WITHOUT MANY APPLICATIONS AND THOSE THAT PRESENT AND APPLY FORMULAS WITHOUT APPROPRIATELY DERIVING THEM. THE BALANCE ACHIEVED WILL GIVE READERS A FUNDAMENTAL UNDERSTANDING OF KEY FINANCIAL IDEAS AND TOOLS THAT FORM THE BASIS FOR BUILDING REALISTIC MODELS, INCLUDING THOSE THAT MAY BECOME PROPRIETARY. NUMEROUS CAREFULLY CHOSEN EXAMPLES AND EXERCISES REINFORCE THE STUDENT'S CONCEPTUAL UNDERSTANDING AND FACILITY WITH APPLICATIONS. WHILE NO BACKGROUND IN FINANCE IS ASSUMED, PREREQUISITE MATH COURSES INCLUDE MULTIVARIABLE CALCULUS, PROBABILITY, AND LINEAR ALGEBRA. THE AUTHORS INTRODUCE ADDITIONAL MATHEMATICAL TOOLS AS NEEDED. THE ENTIRE TEXTBOOK IS APPROPRIATE FOR A SINGLE YEAR-LONG COURSE ON INTRODUCTORY MATHEMATICAL FINANCE. THE SELF-CONTAINED DESIGN OF THE TEXT ALLOWS FOR INSTRUCTOR FLEXIBILITY IN TOPICS COURSES AND THOSE FOCUSING ON FINANCIAL DERIVATIVES. MOREOVER, THE TEXT IS USEFUL FOR MATHEMATICIANS, PHYSICISTS, AND ENGINEERS WHO WANT TO LEARN FINANCE VIA AN APPROACH THAT BUILDS THEIR FINANCIAL INTUITION AND IS EXPLICIT ABOUT MODEL BUILDING, AS WELL AS BUSINESS SCHOOL STUDENTS WHO WANT A TREATMENT OF FINANCE THAT IS DEEPER BUT NOT OVERLY THEORETICAL.

AFTER MOTIVATING THEIR UNIQUE APPROACH, IN THE FIRST CHAPTER THE AUTHORS INTRODUCE THE CONCEPTS FROM COMPUTABILITY THEORY, PROBABILITY THEORY, INFORMATION THEORY, COMPLEXITY THEORY, AND INFORMATION-THEORETIC SECURITY THAT ARE REQUIRED TO UNDERSTAND THE BOOK CONTENT. IN PART I THEY INTRODUCE THE FOUNDATIONS OF HASH FUNCTIONS AND MODERN CRYPTOGRAPHY. THEY COVER A NUMBER OF SCHEMES, CONCEPTS, AND PROOF TECHNIQUES, INCLUDING COMPUTATIONAL

SECURITY, ONE-WAY FUNCTIONS, PSEUDORANDOMNESS AND PSEUDORANDOM FUNCTIONS, GAME-BASED PROOFS, MESSAGE AUTHENTICATION CODES, ENCRYPTION SCHEMES, SIGNATURE SCHEMES, AND COLLISION-RESISTANT (HASH) FUNCTIONS. IN PART II THE AUTHORS EXPLAIN THE RANDOM ORACLE MODEL, PROOF TECHNIQUES USED WITH RANDOM ORACLES, RANDOM ORACLE CONSTRUCTIONS, AND EXAMPLES OF REAL-WORLD RANDOM ORACLE SCHEMES. THEY ALSO ADDRESS THE LIMITATIONS OF RANDOM ORACLES AND THE RANDOM ORACLE CONTROVERSY, THE FACT THAT UNINSTANTIABLE SCHEMES EXIST WHICH ARE PROVABLY SECURE IN THE RANDOM ORACLE MODEL BUT WHICH BECOME INSECURE WITH ANY REAL-WORLD HASH FUNCTION. FINALLY IN PART III THE AUTHORS FOCUS ON CONSTRUCTIONS OF HASH FUNCTIONS. THIS INCLUDES A TREATMENT OF ITERATIVE HASH FUNCTIONS AND GENERIC ATTACKS AGAINST HASH FUNCTIONS, CONSTRUCTIONS OF HASH FUNCTIONS BASED ON BLOCK CIPHERS AND NUMBER-THEORETIC ASSUMPTIONS, A DISCUSSION OF PRIVATELY KEYED HASH FUNCTIONS INCLUDING A FULL SECURITY PROOF FOR HMAC, AND A PRESENTATION OF REAL-WORLD HASH FUNCTIONS.
